City Council to establish decorum at meetings

HOLYOKE – The City Council voted 8-5 to pass an amendment to their decorum rule, adding the words "or city employees" after the words "another member."

The purpose of this amendment was to encourage the councilors to treat all city employees who approached the council with respect.

"The charter and rules committee voted 2-1 to recommend this rule change to the full body with the hope of affirming our common value of respecting city employees, many of whom are called here to present to us," Councilor Meagan Magrath-Smith said.

Several councilors reported that city employees had said to them that they felt uncomfortable approaching the council due to the lack of respect they felt they received in council chambers.

"They [city employees] deserve to be treated with respect, they are not members of the general public and, quite frankly, they don't love coming before us because of the way they're treated by some councilors, so I think it's a good thing to put those words in," Councilor Patti Devine said.

Councilors in favor of this amendment also emphasized that this rule was not to prevent needed questioning of city employees, criticism of actions or to censor anyone.

"It was agreed that the purpose of this rule is not to silence legitimate criticism or to use decorum as a tool for censorship," Magrath-Smith said

However, some councilors raised doubts as to whether or not this rule could be used for censorship.

"It depends on what the definition of decorum is, some people could use that for censorship," Councilor Howard Greaney said.

Councilor Kevin Jourdain brought up his own concerns regarding the rule. He felt the rule was a political move and meant to be divisive for the council.

Councilor Kocayne Giver, who had filed the initial order to create this amendment, replied that she had made the motion in good faith.

"I just wanted to clarify

The cast had rehearsals each week night for several hours a night so they could be prepared for this performance.



Library hosts 'campfire' stories by Goodwin

HOLYOKE – The library hosted campfire stories, performed by Storyteller and Song Singer Todd Goodwin, for children of all ages.

Goodwin travels around Massachusetts and performs a collection of songs and stories for children of all ages.

"For me it's the joy of sharing stories with kids of all ages," he said. "I do programs for kids of all ages."

Throughout the program he will do a "name that tune" and play campfire games, such as Simon Says, to help keep children engaged.

He also introduces his FIRE rules: make Friends, gather Inspiration, give Respect, and bring Energy and Enthusiasm.

Goodwin performs different songs, both singing and playing them on the harmonica, and then peppers in stories.

"I've taken some old camp songs that I've learned from when I was a kid and then created a story around that, so it makes sense to do the songs and stories together," Goodwin coid

ent stories from New England traditions, from my work as a science teacher, I've used some Native American stories...some from fairytales, stuff like that," he said.

He enjoys trying to gather stories from different cultures, ones that children may not have heard before.

"I've gathered stories from all over the world...one reason I come to the library is to read stories from books," Goodwin

Goodwin particularly loves performing at different libraries in the area.

"I'm always glad to come to libraries," he said. "Libraries have always been a place for the community to gather...and they are also a place where people can come to share ideas. I always look for libraries when I'm traveling."

Goodwin truly enjoys this work, finding joy in meeting new people and getting to travel to so many different areas.

"This is like the best part of teaching where you get to share stories and, also, more and more getting to know people from all walks of life," Goodwin said.

Goodwin has long been involved in this kind of work. He grew up going to different summer camps where they would have campfire performances. From there he became a counselor in training, a counselor and a camp director.

that I had no divisive intentions. It's not political," she said. "It was in good faith just to say, 'hey let's be a little more conscious of how we're treating people."

Additionally, Jourdain was concerned this rule could prevent councilors from asking important questions of city employees.

"As a watchdog organization of this entire government we, by nature, make people uncomfortable," he said. "We ask, and we go there, when things aren't right...In the future we need to ask tough questions and direct questions and get to the bottom of things and matters because if we don't, who does?'

Councilor Juan Anderson Burgos replied that this rule was not focused on preventing those "tough questions," but rather on ensuring that city employees would be treated with respect in council

"I do ask hard questions...which we should, we should be asking those hard questions because that's the position

we're in," he said. "That's one thing. But then I look at this order and what it's telling me is I know that I would go in good faith and I would never rip down someone, disrespect, talk to them in a way that would make them feel extremely uncomfortable and I'm not talking about asking hard questions...I think what we need to look at is respectful decorum, and that's it."

Councilor Linda Vacon felt that adding this to the rules would ultimately not make a difference in council behavior.

"No selective choosing of a group of people is going to cause anyone to behave differently," she said. "I believe the rule is adequate, I believe it says how we want to conduct ourselves and I think if we simply commit to following the rule as it exists we wouldn't have any need to add any further language to it."

Councilors Greaney, Jourdain, Vacon, David Bartley and Carmen Occasio voted against this amendment. The vote was 8-5 in favor of the amendment, so the change was made to the council rules.

Last year, the September job fair drew more than 40 employers, representing over 10 industries, and nearly 400 candidates.



Keep mental health in mind during April vacation week

HOLYOKE - Breaks during the school year are meant to benefit students' mental and physical health, providing time to rest and relax and, with April Vacation set to begin the week of the 14th, opportunities to enjoy outdoor fun as New England welcomes warmer stretches of weather.

However, less structured days and less contact with school supports can make some students feel isolated and disconnected. Parents and other caregivers are encouraged to plan ahead, possibly incorporating some new experiences into the break, and talking about other possibilities for socialization and boredom prevention.

It can be a good time, too, to ask a

child about any prolonged changes in mood or behavior and consider a call to their pediatrician.

"Breaks in routine can be challenging for students who find emotional support in their day-to-day interactions," said Khadene Harry-Stoby, Adolescent Unit Nurse manager for MiraVista Behavioral Health Center. "It is good to be aware and ask as early intervention is the best treat-

Transplanting your homegrown seedlings

bet there are a few garden enthusiasts out there with seedlings up and growing

My tomatoes are just poking through, but my peppers are ready for transplanting. Why transplant you ask? It's important that we give our young plants room to spread out!

If seeds were sown in rows, chances are that several seedlings have sprouted and are now growing within a close proximity to one another. They are competing for nutrients and moisture.

Even if two seeds were sown in a single cell of a six-pack and both germinated, they too are competing with one another in that tiny of a space. So, if we want garden center quality seedlings, we must transplant them to their own cell or small pot.

You know a seedling is ready for transplant when it has its "true leaves," not the cotyledon leaves that were first to sprout from the seed, but those that come right after. At this point in growth plant roots aren't tangled up and therefore transplant shock can be kept to a minimum.

Although the seedlings may be tiny and appear fragile, transplanting them is quite simple.

First, take a wooden plant label or dull butter knife and "cut" into the row of seedlings. Then, use your implement "spatula-style" to remove a small cluster of plants from the bottom up.

I always tell folks to "think brownies!" Be careful to get as many roots as you can.

Once you've done this it is time to separate them from one another. Gently pull on a leaf, not the stem, to pry them apart.

Think of it this way: the plant has two leaves but only one stem. If it should snap, that's it! Leaves on the other hand, can and will be replaced if accidentally torn off.

Individual seedlings can be planted in small containers or cell packs filled with soilless growing medium. We steer clear of garden soil because of the pathogens and weed seeds it may contain as well as its tendency not to drain very well.

Soilless mix is sterile, and has the ability to retain moisture yet drain freely- just what the young seedling needs as it grows additional roots and top growth.


Make a hole in the moistened growing medium with your finger, a pencil or wooden dibble. Insert the seedling to the correct depth then firm around it with your fingers.

Most are transplanted to the same depth they were growing in the pack.

One exception is tomatoes; they can be buried deeper than they started out. This is because tomatoes have the ability to make roots along the length of their stem.

Another exception are marigolds. More roots mean healthier shoots!

When should my wife claim her Social Security benefit?



Dear Rusty

I just saw an article which said that certain spousal options were going away, but there are still good options for when a spouse can claim. I am filing for my Social Security to start in October when I turn 70. My wife's Full Retirement Age is in December, and she now plans to file then for half of what my FRA benefit would have been (our original plan was for both to file in August). My wife's main reason for delaying until her FRA is to lock her into my maximum benefit if she has to someday change to Survivor's Benefit. Will this be gone for us? Neither of us was born before Jan. 1, 1954. Please advise.

Signed: Planning for Both

Dear Planning

I expect that the article you refer to was speaking of the option to claim only a spousal benefit first and allow one's personal SS retirement benefit to grow. That option was available only to those who were born before 1954 and had reached full retirement age. As you now know that option is not available to

Assuming your wife's highest benefit entitlement will be as your spouse, your current strategy - you claim your maximum benefit to start in October at age 70 and your wife starts her benefit in December at her FRA is a good one which will yield the maximum possible monthly benefit for both of you. But for clarity, your wife's survivor benefit as your widow has nothing to do with when she claims her spouse benefits now.

The only thing which will affect your wife's benefit as your surviving spouse is her

age when she claims the survivor benefit. If she has already reached her FRA of 66 years and 8 months when you pass, she will get 100% of the amount you were receiving when you died, instead of the smaller spousal amount she was receiving while you were living. Her survivor benefit would only be less than 100% of yours if she claimed it before reaching her full retirement age (which, of course, we hope would not to be the case).

Just so you have the complete picture, your wife could, if desired, claim her Social Security to start at the same time as you in October but, since that would be earlier than her FRA, the amount she would get would be less than 50% of your FRA entitlement. Her spouse benefit would be reduced by 0.694% for each month earlier than her FRA

For example, if your wife starts her spousal benefit in October when your benefit starts, she will get about 98.6% of the amount she would get if she waited until December to start her benefits. That's a permanent reduction, so if your wife's life expectancy is at least average about 87, it's likely still wisest for her to wait until her FRA to start benefits. But in any case, when your wife claims her spousal benefit now will have no effect on the survivor benefit she will get as your future widow.







Water the transplants well with a gentle spray. They can now be put back under the artificial lights you've rigged up.

Continue to keep the lights within inches of the plants for the stockiest growth. Or, if you're lucky enough to have a sunroom or hobby greenhouse, the seedlings will thrive there!

Shade them from direct sun for a few days after transplant to prevent wilting. Soon the roots will recover from the shock of transplant and will again be able to sustain the plant.

Night time temperatures can dip as low as 50 degrees for most plants. In fact, lower night temps will help to ensure the stocky specimen we desire.

Fertilize with half-strength liquid plant food every 10 days to two weeks. Begin to "harden-off" your transplants a couple of weeks prior to putting in the ground.

Thus far they have been kept in a carefully controlled environment. Planting them without a period of acclimatization may mean disaster!

Place them outdoors in a shady spot protected from the wind for only a few hours each day. As the days progress keep them out longer and increase their exposure to bright sun and wind.

Don't forget to water during this process, but forgo all fertilizer.

With less than two months to go until the danger of frost is officially passed, our home grown seedlings won't have long to wait, and neither will we!
